AVAILABILITY: Available for service to permanent residences (primary residence), subject to the established rules and regulations of the Cooperative.

TYPE OF SERVICE: Single-phase, 60 hertz, at available secondary voltages.

RATE: The monthly charges shall be based on the following:

1. Customer Charge: \$30.00 per month

2. Energy Charge with wholesale charges:
 - Summer: For Usage months of June thru September
 - Off Peak kWh \$0.05750 per kWh
 - On Peak kWh: \$0.36250 per kWh**
 - Winter: For Usage months of December thru February
 - First 1,000 kWh: \$0.07700 per kWh
 - Over 1,000 kWh: \$0.05950 per kWh
 - Shoulder: For Usage months of March thru May and October thru November
 - First 1000 kWh \$0.07700 per kWh
 - Over 1000 kWh \$0.06750 per kWh

MINIMUM CHARGE:

The minimum monthly charge shall not be less than the Customer Charge plus 50 kWh of usage during any billing period.

SUMMER SEASON HOURS:

- On-Peak Hours:** From June 1 through September 30 beginning at 2:00 p.m. through 8:00 p.m. local time excluding Sundays and as observed Independence Day and Labor Day.
- Off-Peak Hours:** All hours not defined as On-Peak during the period from June 1 through September 30.

TERMS OF PAYMENT: A late charge of ten percent (10%) will be added to the current monthly charges if payment is not received on or before the fifteenth (15th) day of the month.

FRANCHISE FEE: If a meter is located within a community/city that requires the cooperative to pay franchise fees or taxes, these fees will be calculated and added to the monthly charges accordingly.

TERMS AND CONDITIONS FOR THIS RATE:

1. This rate is only available for service beginning June 1, 2010 for the first 25 residential members that have made application and accept the following rate as a test. Please apply before May 1st.
2. The Cooperative will monitor the effectiveness and reliability of the systems in place to determine that the rate is beneficial to both the member and the Cooperative.
3. Service may continue to be offered following September 30, 2010 if the Cooperative determines that the test was beneficial.
4. Should the test year prove beneficial to the Cooperative and the membership, then the rate shall continue for future years.
